## **Department News:**

# People



Craig Clunas has been continuing to work on the drafts of his Mellon Lectures on 'Chinese Painting and its Audiences' for the Spring of 2012, as well as spending more time on the preparatory work for a major exhibition to be held at the British Museum in 2014, called 'Ming: Courts and Contacts', which he will co-curate with Jessica Harrison-Hall. As well as participating in the 'Image and Object' workshop, where he spoke about the then-imprisoned Chinese artist Ai Weiwei, Craig has given papers at a number of conferences. In March he spoke at a workshop on 'Rulers, Palaces. Wider Worlds: Ritual and Cultural Connections', at the Herzog August Bibliothek, Wolfenbüttel, and he participated in the 2011 Association of Art Historians Conference at the University of Warwick, where he spoke on 'Freedom of Brush and Ink: Chinese Literati Painting and Cold War Ideology', in a panel on 'Cold War Ideology and the History of Art'. He gave a paper at the Ming Provincial Courts Conference, Colgate University, USA, on a topic which relates to his forthcoming book, Screen of Kings: Art, Power and Imperial Clan in Ming China. And he gave the keynote address, on 'Beginning and Ending of Chinese Painting', at the Heidelberg Colloguy on East Asian Art History, where he also tried out his stand-up routine (pictured).

Hanneke Grootenboer has co-taught a new Special Subject Course on the Dutch Golden Age, together with colleague from History Dr Geert Janssen. The course is genuinely interdisciplinary whereby visual and verbal documentation are discussed side by side. Included in the course were trips to the Ashmolean Print Room, the Still Life Gallery and the National Gallery in London with Christopher Brown, Director of the Ashmolean Museum.

Geraldine Johnson continues to work on her Cambridge University Press book on the sensory reception of art in Renaissance Italy. She will be giving talks on this research at the College Art Association conference in Los Angeles and at the Renaissance Society of America conference in Washington, D.C., in the early Spring. Recently, she published a catalogue essay on a contemporary Anglo-Iranian sculptor and photographer for an exhibition held during London's Frieze Art Week in October: Reza Aramesh: 'Them Who Dwell on the Earth' (sponsored by Canvas Magazine and Mottahedan Projects). Her responsibilities as Tutor for Admissions at Christ Church have also been keeping her busy, especially during Michaelmas Term.

**Gervase Rosser** and Jane Garnett have a forthcoming article in Art Bulletin (March 2012) which will be a trailer for their book, now complete and awaiting publication, on cults of miraculous images in Italy between 1500 and 2000.

In July, with **Alessandra Buccheri** (DPhil 2009), he led a group of thirteen first and second year BA students on a study tour in Sicily. They visited, sketched and discussed monuments from the diverse cultures of the island: Greek, Arabic, Norman, Baroque and twentieth century. They also swam.

Alastair Wright has written essays on Henri Matisse for forthcoming exhibitions at the Pompidou Centre in Paris and at the Metropolitan Museum in New York. He has also been researching the role played by sculpture in Paul Gauguin's construction of exoticized domestic settings. An essay on T.J. Clark's Image of the People, which appeared as part of the Burlington Magazine's series re-examining classic art historical texts, will be re-published by Thames and Hudson in a collected volume in the New Year. Alastair recently lectured at the University of Reading and continues to serve as editorial chair of the Oxford Art Journal.

Kate Barush (DPhil 2007 - ) has secured a Postdoctoral Research Associate at the Center for Advanced Studies in the Visual Arts at the National Gallery in Washington, D.C. The primary responsibility is to conduct full-time advanced scholarly research in the history, theory, criticism, and historiography of art and architecture under the direction of a dean for various research projects of the Center. Furthermore, research associates are encouraged to pursue their own research projects while at the Center (and have full use of the research facilities).

**Monica Merlin** (DPhil 2009 - ) had an article published in the November issue of the prestigious journal 'Gender and History', entitled 'The Nanjing Courtesan Ma Shouzhen (1548-1604): Gender, Space and Painting in the Late Ming Pleasure Quarter'.

Alex J. Taylor (DPhil 2010 - ) is was awarded the Robert L. Platzman Memorial Fellowship at the University of Chicago and the Terra Foundation for American Art Predoctoral Fellowship at the Smithsonian American Art Museum in Washington DC. He also received the 2011 Terra Foundation for American Art International Essay Prize for his essay 'Unstable Motives: Propaganda, politics and the late work of Alexander Calder.' Drawn from his MSt dissertation, it will be published in the Spring issue of American Art. Alex's review of this year's Venice Biennale appears in the September issue of Art Monthly Australia.

**Christina Anderson** (DPhil 2011) has been awarded the Drapers' Company JRF at Hertford.



Andrew Budge (MSt 2011) has been awarded the Murray Research Studentship to study for a part time PhD at Birkbeck. Andrew's topic will be The Change in Architectural Style looking particularly at the Collegiate Churches founded between 1330 and 1370.

Rachel Dedman (BA 2011) has been awarded the Von Clemm Fellowship for 2012/13 and so will be embarking on postgraduate study in the History of Art Department at Harvard next year, focussing upon Contemporary Middle-Eastern Art. She will be going as a Special Student, and an ambassador for the Von Clemm Foundation, which connects Oxford and Harvard. Rachel plans to construct a tailor-made course of study, and hope to take a range of courses in politics, literature and language, to complement her emphasis on visual culture.

Holly Harris (BA 2011) is now Head of Fundraising for a charity called QK House, and is charge of managing fundraising events, website design, marketing campaigns and celebrity endorsement. Here is the official line of the charity: 'QK House will aim to provide a safe, stable and focused environment for Sixth Form students who find themselves in a situation that forces them to become homeless. Every year we experience large numbers of sixth form students who face the prospect of homelessness, and many of whom do in fact become homeless. Of course you will know that until recently these young people have been placed in local hostels in central London – unfortunately this is no longer an option for many of these students and they are absolutely desperate for some real and much needed help. QK House aims to do just that.'
